ISSUE PRICE OF NEW UNITS TO BE ISSUED PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR THE 3Q FY15/16 DISTRIBUTION

Further to the Announcement dated 25 January 2016 by Mapletree Logistics Trust Management Ltd., as manager (the "Manager") of Mapletree Logistics Trust ("MLT") in relation to the application of the distribution reinvestment plan ("DRP") to MLT's distribution for the three months ended 31 December 2015 (the "3Q FY15/16 Distribution"), the Manager wishes to announce that the issue price of the new units in MLT ("Units") to be issued under the DRP is S\$0.9176 per Unit.

The issue price represents a 1%¹ discount to the adjusted volume-weighted average traded price² per Unit ("adjusted VWAP") for all trades on Singapore Exchange Securities Trading Limited (the "SGX-ST") during the period of 10 market days prior to and ending on the Books Closure Date ("BCD") on 2 February 2016.

The notice of election is expected to be despatched to all Eligible Unitholders³ on 10 February 2016 for which an Announcement will be issued accordingly.

¹ The issue price represents effectively a 2% discount to the volume-weighted average traded price per Unit for all trades on the SGX-ST during the period of 10 market days prior to and ending on the BCD.

² The adjusted VWAP is computed based on the volume-weighted average traded price per Unit for all trades on the SGX-ST for each of the market days during the period of 10 market days prior to and ending on the BCD and subtracting the 3Q FY15/16 Distribution of 1.87 cents per Unit for each of the market days prior to the first day of "ex-distribution" trading.

³ "Eligible Unitholders" means persons registered as unitholders of MLT in the Depository Register as at 5.00 p.m. on the Books Closure Date of 2 February 2016 and with registered mailing address in Singapore.
