The Listed Issuer, ARA US Hospitality Trust, is a stapled group comprising ARA US Hospitality Property Trust ("ARA H-REIT") and ARA US Hospitality Management Trust ("ARA H-BT"). Each Stapled Security comprises one unit in ARA H-REIT stapled to one unit in ARA H-BT. ARA H-REIT is managed by ARA Trust Management (USH) Pte. Ltd. (the "REIT Manager") while ARA H-BT is managed by ARA Business Trust Management (USH) Pte. Ltd. (the "Trustee-Manager").

The Managers have announced the issuance of an aggregate of 455,654 new Stapled Securities on 30 July 2019 for the payment of the base fee component of the REIT management fee and the Trustee-Manager management fee by way of issue of new Stapled Securities.

The 455,654 new Stapled Securities comprise:

(a) 227,827 Stapled Securities payable to the REIT Manager as payment of the base fee component of the REIT management fee; and

(b) 227,827 Stapled Securities payable to the Trustee-Manager as payment of the base fee component of the Trustee-Manager management fee.

The percentage of stapled securityholdings "immediately after the transaction" are each computed based on 566,364,654 Stapled Securities in issue as at 30 July 2019.
