1. INTRODUCTION

The Board of Directors of TWPH (the "**Board**") wishes to announce that Tien Wah Properties Sdn. Bhd. ("**TWP**" or the "**Assignor**"), a wholly-owned subsidiary of the Company, had on 24 December 2024 entered into a Deed of Assignment ("**Assignment**") with Tien Wah Press Services Sdn. Bhd., a wholly-owned subsidiary of TWP ("**TWPS**" or the "**Assignee**"), which in turn is a wholly-owned subsidiary of the Company for the transfer of all the rights, title and interests of the Assignor and the full benefits granted thereby and all stipulations and all remedies for enforcing the same contained in the Tenancy Agreement dated 16 August 2024 ("**Tenancy Agreement**") entered into with Toyoma Aluminium Foil Packaging Sdn. Bhd. ("**TAFP**" or the "**Landlord**"), for the rental of a multipurpose banquet hall located at 6th Floor in a food and beverage mall known as "New Ocean World Fine Food City" ("**F&B Mall**") which is situated at No. 15, Jalan 19/1, 46300 Petaling Jaya, Selangor, Malaysia ("**Demised Premises**") for the tenancy period commencing from 1 August 2024 to 31 July 2030, subject to the terms and conditions contained in the Tenancy Agreement.

2. BACKGROUND

2.1 Information on TWPS

TWPS is a company incorporated in Malaysia on 13 December 2024. The principal activity of TWPS is food and beverages, event management and investment holding.

The issued and paid-up share capital of TWPS is RM1.00 of 1 ordinary share. The Directors of TWPS are Mr Lee Chee Whye and Ms Lim Wei Mun. TWPS is a wholly-owned subsidiary of TWP, which in turn is a wholly-owned subsidiary of the Company.

2.2 Salient Terms and Conditions of the Assignment

The salient terms and conditions of the Assignment include, amongst others, the following:

(1) In accordance with the Clause 3.8 of the Tenancy Agreement, it provides that TWP (being the tenant) shall not assign, sublet, part with possession

or permit any other person or persons to occupy the Demised Premises in whole or in part without the prior written consent of the Landlord.

- (2) On 24 December 2024, the Landlord has provided its consent for such assignment from the Assignor to Assignee.
- (3) In consideration of RM10.00 by the Assignee to the Assignor, the Assignee agrees to be bound by the terms of the Tenancy Agreement, the Assignor HEREBY ASSIGNS ABSOLUTELY UNTO to the Assignee and the Assignee hereby accepts the Assignment.

3. RATIONALE AND BENEFITS OF THE ASSIGNMENT

The Group intends to reorganise its internal structure by assigning the Tenancy Agreement from TWP to TWPS to streamline the event spacing leasing to be more efficient.

The Assignment will allow TWPS to re-mobilise the lease in order for TWPS to lease New Ocean World Fine Food City so that the Group can diversify their business interest beyond the traditional printing business.

4. **RISK OF THE ASSIGNMENT**

The Board does not expect any material risks arising from the Assignment as the risks are limited to the non-fulfilment of the terms and conditions of the Assignment which are mainly administrative and are unlikely to impact the completion of the Assignment.

5. EFFECTS OF THE ASSIGNMENT

The Assignment will not have any material effect on the earnings per share, net assets per share, gearing, share capital and substantial shareholders' shareholdings of the Group for the financial year ending 31 December 2024.

6. APPROVAL REQUIRED

The Assignment is not subject to the approval of the shareholders of TWPH or any regulatory authorities.

YM Tengku Djan Ley Bin Tengku Mahaleel is an Independent Non-Executive Director of the Company. He is the son of Tengku Mahaleel Bin Tengku Ariff which is a Director and shareholder of TAFP.

The aforementioned are all persons connected to NTIH and TAFP. Therefore, Mr Yen Wen Hwa (Ngan Tzee Manh), Ms Angela Heng Chor Kiang, Mr Lee Chee Whye and YM Tengku Djan Ley Bin Tengku Mahaleel ("Interested Directors" or "Related Party") are deemed interested in the Assignment. The Interested Directors have abstained and will continue to abstain from all board deliberations and voting in respect of the Assignment.
