Prime Marine Corporation's subsidiary, Prime Investments and Holdings Ltd is the holding company of Prime Shareholdings Inc. which owns 100% shares in FSL Holdings Pte. Ltd. ("FSLH"). Therefore, Mr Efstathios Topouzoglou is deemed interested in all of the units held by (i) FSLH; and (ii) FSLH's indirect subsidiary, FSL Trust Management Pte. Ltd. in First Ship Lease Trust.
