NTEGRATOR SECURES EIGHT CONTRACTS WORTH S\$20.1 MILLION FROM REPEAT CUSTOMERS

- *One contract awarded for the supply of services for the installation of fiber cable to provide broadband services for commercial customers*
- *Three contracts awarded by Myanmar Radio and Television for supply of equipment*
- *Three contracts for equipment supply and upgrade of equipment for Vietnam's Viettel Group*
- *Awarded a cable recovery contract from Sino Huawei Technologies*

Singapore, November 3, 2014 – Ntegrator International Ltd (“Ntegrator” or “the Group”), a leading regional communications network specialist and systems integrator, announced that it has secured eight new contracts, worth a total of S\$20.1 million from four repeat customers.

Of the eight contracts, one substantial contract is from a regional service provider for the supply of services for the installation of fiber cable to provide broadband services for commercial customers (the “Fiber Cable Installation Contract”).

Three contracts are for the supply of equipment to Myanmar Radio and Television (“MRTV”), whilst another three are for equipment supply and update for Vietnam's Viettel Group (“Viettel”).

The Group was also awarded a cable recovery contract from Sino Huawei Technologies Pte Ltd (“Huawei”).

Mr. Jimmy Chang, Managing Director of Ntegrator, commented, “We are delighted to be regularly awarded contracts from repeat customers. Even more significant is that these eight new contracts are from customers who were with Ntegrator since our inception in 2002. This is a strong endorsement of customer satisfaction with the quality and delivery of earlier contracts and we look forward to continuing growth with many of our customers in the region.”

This Fiber Cable Installation Contract is scheduled to commence in November 2014 with a contract period term of 3 years (2 + 1). It is therefore expected to contribute positively to the Group’s financial performance in next two financial years.

The three contracts from MRTV are for the supply of TV transmitters, antenna system and Ku-Band uplink system equipment and services. The three equipment supply and update contracts from Viettel are for the supply of Dense Wavelength Division Multiplexing (“DWDM”) and Synchronous Digital Hierarchy (“SDH”) equipment, for the expansion of fiber cable transmission capacity for Viettel in Vietnam and Cambodia. The cable recovery contract from Sino Huawei is for the Singapore market.

The abovementioned contracts are not expected to have a material impact on Group’s EPS and NTA for FY2014.
