## **BOUSTEAD GEOSPATIAL DIVISION AWARDED LANDMARK A\$30M CONTRACT FROM AUSTRALIAN GOVERNMENT**

**Singapore, 24 August 2020**

Mainboard-listed Boustead Singapore Limited (“Boustead” or the “Group”), a progressive global Infrastructure-Related Engineering and Technology Group is pleased to announce that its 88.2%-owned business unit, Esri Australia Pty Ltd (“Esri Australia”) – Australia’s leading geographic information systems (“GIS”) technology and services provider, and exclusive distributor of the world-leading Esri ArcGIS platform – has secured a A\$30 million contract (approximately S\$29 million) (the “Contract”) with an Australian federal government department.

The Contract involves a multi-year Enterprise Agreement that will see Esri Australia provide thousands of Australian government employees with access to state-of-the-art GIS technology. It represents a renewal of an existing arrangement, which includes the provision of the Esri ArcGIS platform and after-sales software support services.

Managing Director of Esri Australia, Brett Bundock said, “While Esri Australia has worked with the Australian government agencies for more than thirty years, it has only been in the past half decade that applied spatial thinking has informed the highest levels of government. The changing nature of the challenges facing today’s leaders has made the science of geography and spatial analysis a critical decision-making tool for the more entrepreneurial governments throughout our region. This Contract demonstrates a clear commitment to prioritising progressive spatial approaches to address both local and regional challenges.”

The ArcGIS platform has also recently supported the efforts of Australia’s federal, state and local governments in responding to national crises including the 2019/2020 Australian bushfires and the COVID-19 pandemic. The ArcGIS platform has been used to develop near-real time COVID-19 dashboards and hubs that enable government leaders and the broader communities to understand the impact of the virus, track the spread and map a road to recovery.

Boustead’s Geospatial Division is ranked among the top exclusive distributors in Esri Inc’s global network, with a client base numbering over 13,000 organisations regionally across the Asia Pacific, including Australia, Singapore, Malaysia, Indonesia, Bangladesh, Brunei, Papua New Guinea and Timor-Leste.

The Contract is expected to have a positive material impact on the profitability and earnings per share of the Boustead Group in the current financial year ending 31 March 2021 (“FY2021”) but is not expected to have a material impact on net tangible asset value per share for FY2021.

None of the Directors or controlling shareholders of Boustead has any interest, direct or indirect, in the Contract.
