The board of Directors (the "Board") of Capital World Limited (the "Company") refers to the announcements dated (i) 8 February 2018 in relation to the Convertible Bonds Subscription Agreement ("Subscription Agreement") entered into with Dato' Sri Chong Thim Pheng; (ii) 21 March 2018 in relation to the receipt of the listing and quotation notice; (iii) 27 April 2018 on the results of extraordinary general meeting ("Announcements") as well as the Circular.

The Board wishes to announce that 19,512,195 Facility Shares following the drawdown of Series A Tranche 1 Bonds and 14,634,146 Facility Shares following the drawdown of Series A Tranche 2 Bonds under the Convertible Bonds Subscription Agreement, were allotted and issued by the Company to Prosper Network Co., Ltd ("Allotment and Issuance"), pursuant to the Arranger Agreement. The 34,146,341 Facility Shares are expected to be listed on the SGX-ST on 8 May 2018.

The abovementioned Facility Shares will rank for any dividends, rights, allotment or other distributions, the record date for which is on or after the date of issue and allotment of the Facility Shares and will rank *pari passu* in all respects with the then existing Shares.

Following the Allotment and Issuance, the total number of issued and paid-up ordinary shares of the Company has increased from 1,268,314,067 shares to 1,302,460,408 shares.
