**FINANCIAL UPDATE FOR THE THIRD QUARTER ENDED 30 SEPTEMBER 2018**

---

The Board of Directors of Global Palm Resources Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) wishes to announce that, following a preliminary review of the unaudited financial statements for the quarter ended 30 September 2018 (“**3Q2018**”), the Group is expected to report a substantially lower net profit, or maybe a loss, after tax, as compared to the preceding quarter ended 30 September 2017.

The lower net profit/(loss) after tax is primarily attributable to the decrease in the sales volume and average selling price of crude palm oil and decrease in average selling price of palm kernel.

The Group is still in the process of finalizing its unaudited financial results for 3Q2018. Further details of the performance of the Group will be disclosed in its unaudited financial statements announcement for 3Q2018, which is expected to be released on or before 14 November 2018.
