Further to our disclosure last 27 June 2026 on the submission of our affiliate, Mynt, Inc. ("Mynt") of a registration statement with the Securities and Exchange Commission ("SEC") and a listing application with the Philippine Stock Exchange ("PSE"), we disclose that Mynt has received the pre-effective letter ("Pre-Effective Letter") from the SEC, favorably considering Mynt's proposed initial public offering ("IPO") of up to 8,027,409,600 common shares with an over-allotment option of up to 1,204,111,400 secondary common shares. The proposed IPO remains subject to the fulfillment of the conditions set forth in the Pre-Effective Letter, the SEC's issuance of a Permit to Sell, the approval by the PSE of Mynt's listing application, prevailing market conditions, final offer terms, and internal approvals and consents, among others.

We will disclose further details in connection with the IPO at the appropriate time.
