Soleado, a wholly-owned subsidiary of Thoresen Thai Agencies Public Company Limited, acquired 206,700 ordinary shares in the capital of Sino Grandness Food Industry Group Limited (the "Soleado Shares"). Mr. Chalermchai Mahagitsiri holds more than 20% direct and deemed interest in TTA. Pursuant to Section 4 of the Securities and Futures Act, Mr. Chalermchai Mahagitsiri is deemed to be interested in any shares in which TTA has an interest, including any shares in which TTA's wholly-owned subsidiaries, Soleado, has an interest. Accordingly, Mr. Chalermchai Mahagitsiri is deemed to be interested in the Soleado shares.

In addition, PM Group Company Limited ("PM Group") earlier acquired 25,398,965 ordinary shares in the capital of Sino Grandness Food Industry Group Limited (the "PM Group Shares"). Mr. Chalermchai Mahagitsiri holds a controlling interest in PM Group. Pursuant to Section 4 of the Securities and Futures Act, Mr. Chalermchai Mahagitsiri is deemed to be interested in any shares in which PM Group has an interest. Accordingly, Mr. Chalermchai Mahagitsiri is deemed to be interested in the PM Group Shares.
