- (iv) Sienna Pte. Ltd. ("Sienna") holds 21.0948% of Units.
- (v) Kent Assets Pte. Ltd. ("Kent Assets") holds 8.7833% of Units.
- (vi) Suffolk Assets Pte. Ltd. ("Suffolk Assets") holds 5.3945% of Units.
