R&R and A&A specialist, ISOTeam, lifts order book with \$22.2 million in new public and private sector contracts

- Strengthens market position with R&R projects for public housing and food centres, together with a Neighbourhood Renewal Programme (NRP) project totalling \$18.9 million;
 - Also secures interior design projects totalling \$3.3 million

SINGAPORE – 16 December 2014 – ISOTeam Ltd. (the "Company" or "ISOTeam" and together with its subsidiaries, the "Group"), an established eco-conscious Repairs and Redecoration ("R&R") and Addition and Alteration ("A&A") specialist in Singapore, today announced it has been awarded nine new contracts worth approximately \$22.2 million.

Reaffirming its leading position in the local R&R market, the Group secured six projects totalling approximately \$15.4 million for R&R works to 90 blocks of HDB flats and three food centres which are expected to be delivered over a period of the next 15 months. ISOTeam also continued to lead the pack in the A&A segment by sealing a Neighbourhood Renewal Programme ("NRP") contract at Kim Keat Avenue and Kim Keat Link for the Bishan-Toa Payoh Town Council worth \$3.5 million. This NRP project is expected to be completed in April 2016.

Making dynamic progress in its Interior Design ("ID") business, the Group clinched a major ID project to repair and refurbish Aloha Loyang for the Public Service Division, The Prime Minister's Office worth \$3.2 million which it expects to complete this work by July 2015. In addition to that, the Group also successfully extended its services to the public schools by securing its first contract for renovation work at Methodist Girls' School at 11 Blackmore Drive worth \$0.1 million and this project is expected to be completed in December 2014.

Said Mr Anthony Koh (许统发), Executive Director and Chief Executive Officer of ISOTeam, on the Group latest contract wins, "ISOTeam's market leadership position in the R&R and A&A sector is further strengthened by these nine projects, which have substantially raised our order book. In addition, we secured two of the nine contracts even though we were not the lowest tenderer, lending the Group much credibility as a preferred partner with our track record for delivery and quality."

He added, "This round of contract wins also sees us delivering on our business expansion strategy to extend our services to other sectors with our first public school contract. We will continue to strive to win more such contracts, as well as continue the strategy to penetrate other untapped areas such
