Each Stapled Security comprises one unit in ARA H-REIT stapled to one unit in ARA H-BT. ARA H-REIT is managed by ARA Trust Management (USH) Pte. Ltd. (the "REIT Manager") while ARA H-BT is managed by ARA Business Trust Management (USH) Pte. Ltd..

The percentage of stapled securityholdings set out above is calculated on the basis of 567,342,368 outstanding Stapled Securities in issue as at 03 March 2020.
