In addition, shareholders who are unable to attend will not be permitted to appoint proxies to attend in their place.

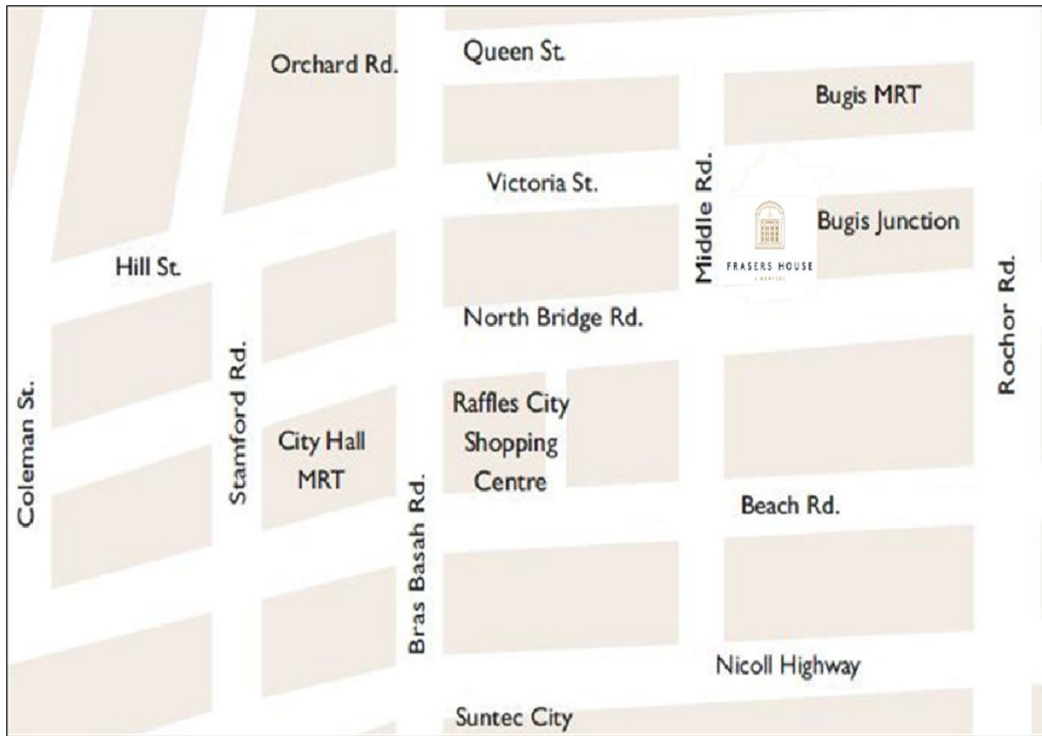
