### UPDATE ANNOUNCEMENT

The Board of Directors (the "Board" or the "Directors") of the Company refers to its announcement released on 21 October 2018 (the "1<sup>st</sup> Holding Announcement").

The Company had disclosed in the 1<sup>st</sup> Holding Announcement that AIHL, the Company's controlling shareholder, which directly holds 73.78% of the shareholding interest in the capital of the Company, was in preliminary discussions with potential investors in relation to the Potential Transaction, which if consummated, may or may not lead to a disposal of AIHL's entire shareholding interest in the Company to such potential investors.

Further to the 1<sup>st</sup> Holding Announcement, the Board wishes to update shareholders on the status of the abovementioned preliminary discussions. As the Company understands, discussions with the potential investors are still ongoing and there is no certainty or assurance that these discussions will result in any transaction.

The Company will make the appropriate announcements when there are any material developments regarding the Potential Transaction in compliance with the relevant provisions of the Listing Manual Section B: Rules of Catalist of the Singapore Exchange Securities Trading Limited.

The Directors (including any who may have delegated detailed supervision of this announcement) have taken all reasonable care to ensure that the facts stated and all opinions expressed in this announcement are fair and accurate and that there are no material facts not contained in this announcement, the omission of which would make any statement in this announcement misleading.
