**APPLICATION FOR AN EXTENSION OF MORATORIA
PURSUANT TO SECTIONS 211B AND 211C OF THE COMPANIES ACT**

1. INTRODUCTION

- 1.1 The Board of Directors ("**Board**") of Libra Group Limited (the "**Company**"), along with its subsidiaries and associated companies (the "**Group**"), refers to the Company's announcements dated 17 September 2019 and 20 September 2019, 24 September 2019, 14 October 2019, 15 November 2019, 2 April 2020, 9 April 2020, 14 April 2020, 31 July 2020, 21 August 2020 and 19 October 2020 in relation to, *inter alia*, the Company's application to the High Court of Singapore under Section 211B of the Companies Act, and the application by Kin Xin Engineering Pte Ltd ("**KXE**") to the High Court of Singapore under Section 211C of the Companies Act for a moratorium (collectively, the "**Moratoria**") (collectively, the "**Previous Announcements**").
- 1.2 Unless otherwise defined, all capitalised terms and references used herein shall bear the same meaning ascribed to them in the Previous Announcements.

2. APPLICATION FOR AN EXTENSION OF THE MORATORIA

- 2.1 The 3rd Moratoria Extension Applications have been re-fixed to be heard via video-conference on 30 October 2020 at 5pm ("**Hearing**") instead of 30 October 2020 at 3:30pm. In addition, the Court also directed the following:
- 2.1.1 Creditors objecting to the 3rd Moratoria Extension Applications are to file their reply affidavits by 26 October 2020, 4pm;
- 2.1.2 The Company and KXE are to file their reply affidavits by 30 October 2020, 4pm;
- 2.1.3 At the hearing on 30 October 2020, the Court will not deal substantively with the 3rd Moratoria Extension Applications, but will deal only with HC/SUM 4521/2020 and grant a short interim extension until the next hearing (as well as to give any other directions which parties may require); and
- 2.1.4 Parties are to write in by 26 October 2020 on their availability of a substantive hearing of the 3rd Moratoria Extension Applications at the following timeslots: (i) 3 November 2020 at 10:00am, (ii) 3 November 2020 at 2:30pm, (iii) 4 November 2020 at 10:00am or (iv) 4 November 2020 at 2:30pm.
- 2.2 Creditors who are interested to attend the Hearing and/or object to HC/SUM 4521/2020 should inform the Company of its intention by no later than 5pm on 27 October 2020.
- 2.3 The Company will make further announcements to update its shareholders when there are material updates as may be necessary or appropriate.
