EXERCISE OF CALL OPTION FOR THE DIVESTMENT OF PULLMAN CAIRNS INTERNATIONAL

Further to the announcement dated 15 May 2015, Ascendas Hospitality Fund Management Pte. Ltd., the manager of Ascendas Hospitality Real Estate Investment Trust and Ascendas Hospitality Trust Management Pte. Ltd., the trustee-manager of Ascendas Hospitality Business Trust ("A-HBT"), are pleased to announce that the nominees of Shakespeare Property Group Pty Ltd, being Equity Trustees Limited as trustee for the Shakespeare Cairns Hospitality Business Trust (collectively referred to as "Purchasers") have today exercised the call option ("Call Option") pursuant to the terms of the put and call option deed entered into between Notron No 346 Pty Ltd (in its capacity as trustee for Notron No 346 Trust), Ascendas Cairns International Pty Limited and Polaris Developments Pty Limited ¹ (collectively known as "Vendors"), and Shakespeare Property Group Pty Ltd on 15 May 2015.

Following the exercise of the Call Option, the Vendors and the Purchasers are deemed to have entered into the sale and purchase agreement (**"SPA**") in relation to the divestment of Pullman Cairns International (**"Divestment**"). The Divestment is expected to be completed by 30 June 2015.
