On 6 May 2024, RHB disposed of 455,000 ordinary shares in the capital of NCL ("NCL Shares") held on behalf of RHB (Singapore branch) in its RHB Bank Nominees Pte Ltd account via market transaction for a consideration of S\$58,230.90. As a result of the above transaction, RHB's percentage level of deemed interest in NCL changed from 10.10% to 9.98%. The above amount of consideration has not taken into account the brokerage fees paid.

RHB is deemed to be interested in the 30,177,564 NCL Shares held on behalf of RHB (Singapore branch) in its RHB Bank Nominees Pte Ltd account and 114,900 NCL Shares held on its behalf in its RHB Nominees (Tempatan) Sdn Bhd account. RHB Bank Berhad is also deemed to be interested in the 8,868,453 NCL Shares held by it wholly-owned subsidiary, RHB Bank (L) Ltd.
