## **UPDATES ON THE GROUP'S OPERATIONS IN RELATION TO COVID-19**

- 1. The Board of Directors (the "Board" or the "Directors") of Aoxin Q & M Dental Group Limited (the "Company", and together with its subsidiaries, the "Group") refers to its announcements dated 22 March 2022 and 11 May 2022 and wishes to provide an update in relation to COVID-19 on the Group's operations in Liaoning Province, People's Republic of China ("PRC").
- 2. The Group wishes to announce that the following dental polyclinics had consecutively resumed operations after we have fulfilled the required standard operating procedures and have met the reopening criteria governed by the respective health commissions in the PRC.

- 3. With the resumption of operations of the above polyclinics, the Board is pleased to inform our Shareholders that all of our dental hospitals and polyclinics in Liaoning Province PRC are currently in operation except for Gaizhou City Aoxin Q & M Stomatology Hospital Co., Ltd. which is expected to resume operation soon.
- 4. In addition, our Group's distribution of dental equipment and supplies segment, which was temporarily closed on 24 March 2022, has also resumed operation on 5 May 2022, while our laboratory services segment, which was temporarily closed on 24 March 2022, has also resumed operation on 4 May 2022.
- 5. The above-mentioned temporary closures are expected to have a material adverse impact on the Group's earnings for the first half year ending 30 June 2022.
- 6. The Group will continue to monitor the situation closely, continue to maintain communication with the relevant authorities and adhere to prevailing requirements, including implementing additional short-term precautionary measures, if mandated by the respective health commissions in the PRC.

7. The Board will keep our Shareholders updated on any further material impact of COVID-19 on the Group's business activities.
