- The LTA project is for the supply and installation of electrical services for Cross Island Line Phase 1 and Cross Island Line Punggol Extension.
- The addition of this new project will significantly boost the Group's order book to a record \$\$614.9 million.
- Barring any unforeseen circumstances, the new project is expected to have a positive impact on the net tangible assets and earnings per share of the Group throughout the 5-year duration of the project.
