### USE OF PROCEEDS FROM THE PREFERENTIAL OFFERING

Further to the announcements dated 18 December 2023, 19 December 2023, 21 December 2023, 2 January 2024, 16 January 2024, 18 January 2024 and 11 March 2024 in relation to the fully underwritten *pro rata* and non-renounceable preferential offering (the “**Preferential Offering**”) of 103,354,690 new units in Elite Commercial REIT (“**Elite REIT**”) to eligible unitholders, to raise gross proceeds of approximately £28.0 million, Elite Commercial REIT Management Pte. Ltd., in its capacity as manager of Elite REIT (the “**Manager**”), wishes to announce that it has utilised S\$305,744 (which is approximately £181,141) or approximately 0.6% of the gross proceeds from the Preferential Offering to pay for the fees and expenses, including professional fees and expenses, incurred by Elite Commercial REIT in connection with the Preferential Offering.

Such use of the proceeds is in accordance with the stated use and percentage allocated to such use, as set out in the announcement dated 18 December 2023 announcing the launch of the Preferential Offering. The Manager will make announcements as and when the balance of the gross proceeds from the Preferential Offering is materially disbursed.
