## SGX-Listed InnoTek's Mr Lou Yiliang Named Best CEO at Singapore Corporate Awards 2022

He is also driving InnoTek's strategy to diversify into new sectors to increase revenue streams and to intensify focus on business resilience post-pandemic.

These efforts follow Mr Lou's earlier achievements in leading a multi-year restructuring since he was appointed CEO in November 2015. Under his leadership, the Group has recorded six consecutive years of profitability.

Mr Lou said: "I am deeply honoured by this recognition by SCA; I would like to credit the award to the hard work and dedication of the InnoTek team, as well as the guidance and counsel of our Board of
