PROPOSALS FOR RE-ELECTION OF RETIRING DIRECTORS, GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES, AND NOTICE OF ANNUAL GENERAL MEETING

INTRODUCTION

The purpose of this circular is to provide the Shareholders with details regarding (i) the proposed re-election of the retiring Directors, and (ii) the proposed grant of general mandates to the Directors to issue and repurchase Shares. Such proposals will be dealt with at the Annual General Meeting.

RE-ELECTION OF THE RETIRING DIRECTORS

Mr. SO Haw Herman, aged 36, was appointed as Executive Director on 3 February 2016. He is a holder of a Master Degree of Business Administration at the Hong Kong University of Science and Technology. Mr. SO has experiences in banking services, commercial and residential real estate investment and development, developments and operations in information technology, mergers and acquisitions and general management. Mr. SO had worked in banking and private business group in various industries. Before joining the Group, Mr. SO was an executive director of another Hong Kong Stock Exchange listed company.

A service contract has been entered into between Mr. NG and the Company which is for a term of two years subject to retirement by rotation and re-appointment in accordance with the Articles. Pursuant to his service contract, Mr. NG has received a director's fee of HK\$360,000 for the year ended 31 December 2018 which was determined with reference to his experience, duties and market trends.

Save as disclosed above, there is no information required to be disclosed pursuant to the requirements of Rule 13.51 (2) of the Listing Rules nor are there any other matters that need to be brought to the attention of the Shareholders.

Mr. NG has made an annual confirmation of independence pursuant to the independence guidelines set out in Rule 3.13 of the Listing Rules. The Nomination Committee has assessed the independence of Mr. NG and is satisfied that he is independent and will continue to bring independent and objective perspectives to the Company's affairs.

Both the Board and the Nomination Committee consider the re-election of Mr. HUANG Zhen Qian and Mr. SO Haw Herman as Executive Directors and Mr. NG Man Kung as an Independent Non-executive Director is in the best interests of the Company and the Shareholders as a whole. The proposed re-election of the above Directors will be considered by separate resolutions at the Annual General Meeting.

GENERAL MANDATE

The following is the explanatory statement required to be sent to the Shareholders under the Listing Rules in connection with the Repurchase Mandate proposed to be passed by the Shareholders as an ordinary resolution at the Annual General Meeting.

1. SHARE CAPITAL

It will be proposed at the Annual General Meeting to be held on 17 May 2019 an ordinary resolution to grant the Repurchase Mandate to the Directors up to 10% of the Shares in issue as at the date of the passing of such resolution.

As at the Latest Practicable Date, the authorized share capital of the Company was HK\$200,000,000 divided into 20,000,000,000 Shares, of which 7,748,960,899 Shares were in issue. On such basis (and assuming no further Shares are issued or repurchased by the Company prior to the Annual General Meeting), the Directors would be authorized to repurchase up to 774,896,089 Shares.

2. REASONS FOR THE REPURCHASE

The Directors believe that it is in the best interests of the Company and its Shareholders for the Directors to have a general authority from the Shareholders to enable the Directors to repurchase Shares on the market. Such repurchases may, depending on market conditions and funding arrangement at the time, lead to an enhancement of the net asset value of the Company and/or its earnings per Share and will only be made when the Directors believe that such repurchase will benefit the Company and the Shareholders.

3. FUNDING OF AND IMPACT ON REPURCHASES
