Victory Gate Ventures Limited ("VGVL") held 4,500,000,000 shares in International Cement Group Ltd. ("ICG") and was 70% and 30% held by Mr Zhang Zengtao ("Mr Zhang") and Mr Ma Zhaoyang ("Mr Ma") respectively. At the VGVL level, there was restructuring of ownership where Mr Ma transferred 30% of his stake in VGVL to Mr Zhang, and VGVL transferred 1,350,000,000 shares in ICG to Mr Ma, being 30% of VGVL's shares in ICG. Consequently, VGVL is wholly owned by Mr Zhang. There is no change in effective ownership in ICG by Mr Ma and Mr Zhang.
