## AWARD OF RMB13.648 MILLION WASTE WATER (LEACHATE) TREATMENT PLANT CONTRACT IN CHINA

The Board of Directors (“**Directors**”) of Trittech Group Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) wishes to announce that its indirect wholly-owned subsidiary, 安徽省科林环境生物技术有限公司 (\*Anhui Clean Environment Biotechnology Co Ltd)(“**Anhui Clean Environment Biotechnology**”), had on 27 February 2017 received an award for a project with a contract value of approximately RMB13.648 million (subject to verification by the 安岳县审计局 (\*Anyue County Audit Bureau)) in relation to the design, supply and installation of a waste water treatment system (the “**Waste Water Treatment System**”) for the treatment of the leachate produced from a solid waste treatment plant located in the county of Anyue in the Sichuan Province, the People’s Republic of China (the “**Contract**”) by 安岳县兴安城市建设投资开发有限公司(\*XingAn Urban Investment and Development of Anyue County Co. Ltd of China (“**XingAn Urban Investment and Development**”).

The main scope of the Contract includes, *inter alia*, the design, supply and installation of the integrated process equipment system of the Waste Water Treatment System and follow-up support staff training at Anhui Clean Environment Biotechnology’s expense.

The commencement date for the works in relation to the Waste Water Treatment Plant is 1 March 2017 and the expected completion date is 30 September 2017.

None of the Directors or substantial shareholders of the Company has any interest, direct or indirect, in the Contract (other than through their shareholdings in the Company).

The Contract is not expected to have any material impact on the consolidated earnings per share and/or net tangible assets per share of the Group for the current financial year ending 31 March 2017.
