#### **ANNOUNCEMENT**

#### NOTICE OF:

- (I) PREFERENTIAL OFFERING RECORD DATE; AND
- (II) CUMULATIVE DISTRIBUTION RECORD DATE.

Capitalised terms used herein, but not otherwise defined, shall have the meanings ascribed to them in the announcement of Mapletree Logistics Trust dated 20 October 2020 titled "Launch of Equity Fund Raising to Raise Gross Proceeds of No More Than S\$650.0 million (Including the Upsize Option)" (the "Launch Announcement").

NOTICE IS HEREBY GIVEN that pursuant to the Equity Fund Raising, the Transfer Books and Register of Unitholders of Mapletree Logistics Trust ("MLT") will be closed at 5.00 p.m. on Wednesday, 28 October 2020 for the purpose of determining:

- (i) the provisional allotment of New Units to Eligible Unitholders<sup>1</sup> under the Preferential Offering (the "**Preferential Offering Record Date**"); and
- (ii) the entitlement of Unitholders to a quarterly distribution of 2.055 Singapore cents per Unit for the period from 1 July 2020 to 30 September 2020 ("2Q FY20/21 Distribution") and an advanced distribution of approximately between 0.614 Singapore cents and 0.632 Singapore cents for the period from 1 October 2020 to the date immediately prior to the date on which the New Units are issued pursuant to the Private Placement (as defined herein) (the "Advanced Distribution", and together with the 2Q FY20/21 Distribution, the "Cumulative Distribution") (the record date of the Cumulative Distribution, the "Cumulative Distribution Record Date").

It was announced on 20 October 2020 that the Manager is proposing to carry out an equity fund raising of New Units to raise gross proceeds of no more than S\$650.0 million by way of:

(a) a private placement (the "**Private Placement**") of between 222,003,000 to 228,080,000 New Units at an issue price of between S\$1.973 and S\$2.027 per New Unit, to raise gross proceeds of approximately S\$450.0 million, subject to an upsize option to issue up to 25,342,000

Only Eligible Unitholders (as defined herein) are eligible to participate in the Preferential Offering. "Eligible Unitholders" are Eligible Depositors (as defined herein) and Eligible QIBs (as defined herein). "Eligible Depositors" are Unitholders with Units standing to the credit of their respective securities accounts with CDP as at the Preferential Offering Record Date ("Depositors") and (a) whose registered addresses with CDP are in Singapore as at the Preferential Offering Record Date; or (b) who have at least three Market Days prior to Preferential Offering Record Date provided CDP with addresses in Singapore for the service of notices and documents, but exclude, subject to certain exceptions, Unitholders located, resident or with a registered address outside of Singapore. "Eligible QIBs" are qualified institutional buyers (as defined in Rule 144A under the Securities Act (as defined herein)) that meet certain requirements which will be specified in the instruction booklet to be despatched to Eligible Unitholders in due course.

additional New Units to raise additional gross proceeds of up to approximately S\$ 50.0 million; and

(b) a non-renounceable preferential offering of up to 76,219,658 New Units to Eligible Unitholders at an issue price of between S\$1.940 and S\$1.990 per New Unit (fractions of a New Unit to be disregarded) to raise gross proceeds of up to S\$150.0 million (the "**Preferential Offering**"),

# (together, the "Equity Fund Raising").

The Preferential Offering Record Date and the Cumulative Distribution Record Date are subject to change, at the discretion of the Manager, in consultation with Citigroup Global Markets Singapore Pte. Ltd., DBS Bank Ltd. The Hongkong and Shanghai Banking Corporation Limited, Singapore Branch and Oversea-Chinese Banking Corporation Limited (collectively, the "Joint Global Co-ordinators and Bookrunners") as the Joint Global Co-ordinators and Bookrunners in relation to the Equity Fund Raising, subject to compliance with all applicable laws and regulations (including but not limited to the requirements of the SGX-ST). In the event of any such change, the Manager will announce such new Preferential Offering Record Date, Cumulative Distribution Record Date and/or any other dates in relation to the Equity Funding Raising on SGXNET.

#### The Cumulative Distribution

The quantum of distribution per existing unit in MLT ("**Existing Unit**") under the Cumulative Distribution is currently estimated to be between 2.669 Singapore cents to 2.687 Singapore cents. A further announcement on the actual quantum of the Cumulative Distribution will be made by the Manager in due course.

The next distribution following the Cumulative Distribution will comprise MLT's distributable income for the period from the day the New Units are issued pursuant to the Private Placement, currently expected to be on Thursday, 29 October 2020, to 31 December 2020 (the "**Relevant Period Distribution**"). Quarterly distributions will resume thereafter, unless otherwise announced.

Unitholders whose securities accounts with CDP are credited with Units as at 5.00 p.m. on the Cumulative Distribution Record Date will be entitled to the Cumulative Distribution that will be paid on or around Friday, 4 December 2020.

The Advanced Distribution is intended to ensure that the distributable income accrued by MLT from 1 October 2020 up to the day immediately preceding the date of issue of the New Units pursuant to the Private Placement (which at this point, will be entirely attributable to the Existing Units) is only distributed in respect of the Existing Units, and is being proposed as a means to ensure fairness to holders of the Existing Units.

# Status of New Units issued pursuant to the Private Placement

The New Units issued pursuant to the Private Placement will, upon issue, rank *pari passu* in all respects with the Units in issue on the day immediately prior to the date on which the New Units are issued pursuant to the Private Placement, other than in respect of the Cumulative Distribution and the eligibility to participate in the Preferential Offering.

For the avoidance of doubt, the holders of the New Units to be issued pursuant to the Private Placement will not be entitled to the Cumulative Distribution or be eligible to participate in the Preferential Offering.

# Status of New Units issued pursuant to the Preferential Offering

The New Units issued pursuant to the Preferential Offering will, upon issue, rank *pari passu* in all respects with the Units in issue on the day immediately prior to the date on which the New Units are

issued pursuant to the Preferential Offering including the right to the Relevant Period Distribution as well as all distributions thereafter, other than in respect of the Cumulative Distribution.

For the avoidance of doubt, the holders of the New Units to be issued pursuant to the Preferential Offering will not be entitled to the Cumulative Distribution.

# **Declaration for Singapore Tax Purposes**

- 1. The tax-exempt income component of the distribution is exempt from tax in the hands of all Unitholders. No tax will be deducted at source from this component.
- 2. The other gains component of the distribution is not taxable in the hands of all Unitholders.
- 3. The capital component of the distribution is treated as a return of capital for Singapore income tax purposes. No tax will be deducted at source from this component.
- 4. Tax will be deducted at source from the taxable income component in certain circumstances. The following paragraphs describe the circumstances in which tax will or will not be deducted from the taxable income component of the distribution.
- 5. The following categories of Unitholders will receive a gross distribution (i.e. no tax will be deducted from it):-
  - (a) Unitholders who are individuals and who hold the Units either in their sole names or jointly with other individuals;
  - (b) Unitholders which are companies incorporated and tax resident in Singapore;
  - (c) Unitholders which are Singapore branches of companies incorporated outside Singapore;
  - (d) Unitholders which are body of persons (excluding companies or partnerships) incorporated or registered in Singapore;
  - (e) Unitholders which are international organisations that are exempt from tax on such distributions by reason of an order made under the International Organisations (Immunities and Privileges) Act (Cap. 145); and
  - (f) Unitholders which are real estate investment trust exchange-traded funds which have been accorded the tax transparency treatment.
- 6. To receive a gross distribution, Unitholders in categories (b) to (f) under Paragraph 5 above must complete a prescribed form the "Declaration for Singapore Tax Purposes Form" ("Form A").
- 7. These categories of Unitholders, unless they are exempt from tax because of their own circumstances, will have to pay income tax subsequently at their own applicable tax rates.
- 8. Unitholders in category (a) are not required to submit any form. The gross distribution received by these Unitholders (irrespective of their tax residence status) is exempt from tax if it is not derived through a partnership in Singapore or from the carrying on of a trade, business or profession.
- 9. Tax at the reduced rate of 10% will be deducted from the distribution made to Unitholders which are:-
  - (a) foreign non-individual; and

- (b) qualifying non-resident fund.
- 10. A foreign non-individual Unitholder is one (other than an individual) who is not a resident of Singapore for income tax purposes and:-
  - (a) who does not have any permanent establishment in Singapore; or
  - (b) who carries on any operation through a permanent establishment in Singapore, where the funds used to acquire the Units in MLT are not obtained from that operation.
- 11. A qualifying non-resident fund is one that qualifies for tax exemption under section 13CA, 13X or 13Y of the Income Tax Act that is not a resident of Singapore for income tax purposes and:-
  - (a) does not have any permanent establishment in Singapore (other than a fund manager in Singapore); or
  - (b) carries on any operation through a permanent establishment in Singapore (other than a fund manager in Singapore), where the funds used to acquire the Units in MLT are not obtained from that operation.

For this purpose, a non-resident fund refers to a fund being a non-resident company, a partnership where all partners are non-residents, a trust administered by a non-resident trustee, or a non-resident entity.

- 12. To receive the distribution net of tax deducted at 10%, Unitholders in categories (a) and (b) under Paragraph 9 above are required to complete Form A.
- 13. Beneficial owners of Units in MLT who hold their Units through depository agents will receive:-
  - (a) gross distribution if they are persons described in categories (a) to (f) under Paragraph 5 above; and
  - (b) distribution net of tax deducted at 10% if they are Unitholders described in categories (a) and (b) under Paragraph 9 above.
- 14. To receive gross distribution and distribution net of tax deducted at 10%, depository agents are required to complete the "Declaration by Depository Agents for Singapore Tax Purposes Form" ("Form B") and its annexes.
- 15. Form A and Form B (and its annexes) will be sent to Unitholders and depository agents respectively, by MLT's unit registrar (the "**Unit Registrar**"), Boardroom Corporate & Advisory Services Pte. Ltd. located at 50 Raffles Place #32-01 Singapore Land Tower, Singapore 048623, on or around **Wednesday, 4 November 2020**.
- Unitholders (Form A) and the depository agents (Form B and its annexes) will have to complete the forms legibly and send it to the Unit Registrar such that they are received by 5.00 pm on Wednesday, 18 November 2020. Failure to comply with any of these requirements will render Form A and Form B invalid and the trustee and the Manager of MLT will be obliged to deduct tax at the rate of 17% from the distribution.
- 17. Unitholders who hold Units under the Central Provident Fund Investment Scheme and the Supplementary Retirement Scheme do not have to return any form. They will receive gross distribution

# Important Reminder

Unitholders and depository agents must complete and return the "Declaration for Singapore Tax Purposes Form A and Form B (and its annexes)", respectively to the Unit Registrar's office by 5.00 pm

on Wednesday, 18 November 2020 in order to receive the distribution either at gross or at net (after deduction of tax at 10%) as described above.

# **Declaration in Income Tax Return**

This distribution is considered as income for the year 2021. Beneficial owners of the distribution, other than those who are exempt from tax on the distribution or who are entitled to the reduced tax rate of 10%, are required to declare the gross amount of the taxable income component of the distribution (regardless whether the distribution is paid in cash or in the form of units) as taxable income in their Singapore income tax return for the year of assessment 2022.
