The Listed Issuer is a stapled group comprising Ascendas Hospitality Real Estate Investment Trust ("A-HREIT") and Ascendas Hospitality Business Trust ("A-HBT"). Each unit of the Listed Issuer comprises 1 unit in A-HREIT and 1 unit in A-HBT. The manager of A-HREIT is Ascendas Hospitality Fund Management Pte. Ltd. and the trustee-manager of A-HBT is Ascendas Hospitality Trust Management Pte. Ltd..

The percentage of interest is calculated on the basis of 1,120,414,088 issued units of Listed Issuer.

19,398,200 units were acquired in multiple transactions starting 2015, and reflected in statements of accounts

of private bankers dated 24 February 2016 (for 1,602,600 units) and dated 15 July 2016 (for 17,795,600 units). These 19,398,200 units were inadvertently left out in the 26 July 2016 disclosure made following the purchase of 54,912,500 units through a different private banker.
