On 17 September 2020, Harvest Private Wealth Income Fund 4 SP ("HPWIF4") acquired 626,000 units in the Trust from Harvest Private Wealth Income Fund 1 SP via an off-market transaction (married deal). With the transaction on 17 September 2020 and together with a series of market transactions prior to 17 September 2020 totalling 3,165,000 units in the Trust, HPWIF4's direct interest in the Trust increased from 4.54% to 5.03%.  
 The percentage of unitholdings immediately before and after this transaction as set out above is calculated on the basis of 770,838,655 outstanding units at the time of this announcement.

There is no change in HPWTF's deemed interest in the Trust arising from the transaction on 17 September 2020 since the increase in its deemed interest in the Trust via HPWIF4 is offset by the corresponding decrease in its deemed interest in the Trust via HPWIF1.  
With the transaction on 17 September 2020 and together with a series of market transactions totalling 1,925,000 units in the Trust via HPWIF1 and HPWIF4 prior to 17 September 2020, HPWTF's deemed interest in the Trust increased from 8.25% to 8.50%.  
The percentage of unitholdings immediately before and after this transaction as set out above is calculated on the basis of 770,838,655 outstanding units at the time of this announcement.
