**1. Issuance of the Tranche 2 Notes**

The Board of the Company wishes to announce that an aggregate amount of S\$8,000,000 of the Tranche 2 Notes (Certificate Nos. 201 to 360) has been duly issued to the Subscriber as at 20 April 2016 in accordance with the terms and conditions of the Notes Issue.

The Company will make further announcements on the utilisation of the net proceeds from the Notes Issue as and when the proceeds are materially disbursed.

**2. Allotment and issue of Shares pursuant to the conversion of the Tranche 2 Notes**

The Board wishes to announce that the Subscriber has, on 20 April 2016, exercised its rights to convert five (5) Notes (Certificate Nos. 314 to 318) in respect of the Tranche 2 Notes. The converted Notes, with an aggregate principal value of S\$250,000 will be converted into 96,153,846 Conversion Shares at the Floating Conversion Price of S\$0.0026 for each Conversion Share on 20 April 2016. An aggregate amount of S\$5,900,000 of the Tranche 2 Notes has been converted as of 20 April 2016.

The Floating Conversion Price of S\$0.0026 was determined by taking 90% of the of the average of the traded volume weighted average prices per share for any three (3) consecutive Trading Days as selected by the Subscriber during the 30 Trading Days immediately preceding the relevant Conversion Notices dated, 20 April 2016. The three (3) consecutive Closing Prices per Share selected are as follows:

Pursuant to the aforesaid issue and allotment of 96,153,846 new ordinary shares of the Company, the number of issued share capital of the company shall increase from 1,879,435,772 shares to 1,975,589,618 shares.
