USE OF PROCEEDS FROM THE ISSUE OF S\$280,000,000 4.55 PER CENT. BONDS DUE 2020

Perennial Real Estate Holdings Limited ("**PREHL**") would like to announce that further to the announcements dated 20 April 2016, 21 April 2016, 27 April 2016, 28 April 2016 and 29 April 2016 in relation to its issuance of \$\$280,000,000 in aggregate principal amount of 4-year 4.55 per cent. bonds due 2020 (the "**Bonds**"), approximately \$\$65.3 million of the balance net proceeds from the issue of the Bonds have been utilised towards the repayment of a bank loan taken up by a wholly-owned subsidiary, financing of investments and working capital of the Group.

The use of net proceeds is in accordance with the stated use disclosed in the Offer Information Statement dated 20 April 2016.

Following the above utilisation, the balance of the net proceeds is S\$20.2 million. PREHL will make further announcements via SGXNET when the remaining proceeds of the Bonds issue are materially disbursed.
