Tuan Sing Holdings Limited (the “**Company**”) wishes to announce that for the application of the Tuan Sing Holdings Limited Scrip Dividend Scheme (the “**Scheme**”) to the first and final tax exempt one-tier dividend of 0.6 cent per ordinary share in the capital of the Company (the “**Dividend**”), each new ordinary share is to be issued at S\$0.27. The said issue price is arrived at after a 10% discount to the average of the last dealt prices of the Company’s shares for each of the market days during the price determination period commencing on 5 May 2016 (the Ex-dividend Date) and ending on 9 May 2016 (the “**Books Closure Date**”) (both dates inclusive), which was S\$0.30. Entitlements to the Dividend were based on the shares held by Members as at 5.00 p.m. on the Books Closure Date.

Members approved the Dividend and the allotment and issuance of new shares pursuant to the Scheme at the Company’s Annual General Meeting held on 29 April 2016.
