CLARIFICATION ON REASON OF CESSATION IN ANNOUNCEMENT OF CESSATION AS INDEPENDENT DIRECTOR

(the "**Company**", and together with its subsidiaries, the "**Group**"), refers to the announcement made by the Company on 21 October 2015 ("**Prior Announcement**") in respect of the resignation of the Company's Independent Director Mr Wee Liang Hiam (the "**Announcement of Cessation**"), and wishes to provide further information as follows:-

Further to the Prior Announcement and the detailed reason of Mr Wee Liang Hiam's resignation, Mr Wee would like to further elaborate that the personal reason was associated with his need to have sufficient time to rest and recuperate following his recent surgery. Mr Wee did not believe that he would have the time and energy to critically scrutinise or challenge the assumptions that Management may make in the course of finalizing the steps and proposed solutions that Management is currently considering to undertake to deal with the Company's present difficulties, which Mr Wee may or may not agree with when these are eventually finalised and presented to the Board. Mr Wee would like to clarify that he currently does not have any differences in opinion with the Management or any member of the Board as he had not been informed by the Management or any member of the Board that the Board is required to express an opinion on any proposed solution.
