PROPOSED COMBINATION OF ASCOTT RESIDENCE TRUST AND ASCENDAS HOSPITALITY TRUST BY WAY OF A SCHEME OF ARRANGEMENT – APPOINTMENT OF INDEPENDENT FINANCIAL ADVISER

1. INTRODUCTION

The boards of directors of Ascendas Hospitality Fund Management Pte. Ltd. (as manager of A-HTRUST REIT) (the "<u>A-HTRUST REIT Manager</u>") and Ascendas Hospitality Trust Management Pte. Ltd. (as trustee-manager of A-HTRUST BT) (the "<u>A-HTRUST BT Trustee-Manager</u>" and, collectively, with the A-HTRUST REIT Manager, the "<u>A-HTRUST Managers</u>") refer to the joint announcement issued on 3 July 2019 (the "<u>Joint Announcement</u>") by Ascott Residence Trust ("<u>Ascott Reit</u>") and Ascendas Hospitality Trust ("<u>A-HTRUST</u>") in relation to the Combination.

All capitalised terms used but not defined herein shall have the meanings ascribed to them in the Joint Announcement.

2. <u>APPOINTMENT OF INDEPENDENT FINANCIAL ADVISER</u>

The A-HTRUST Managers wish to announce that Deloitte & Touche Corporate Finance Pte Ltd has been appointed as the independent financial adviser (the "**IFA**") to the directors of the A-HTRUST Managers who are considered independent for the purposes of the Combination ("<u>A-HTRUST Independent Directors</u>") and Perpetual (Asia) Limited (in its capacity as trustee of A-HTRUST REIT) (the "<u>A-HTRUST REIT Trustee</u>").

A scheme document ("<u>Scheme Document</u>") containing, *inter alia*, full details of the Combination and the A-HTRUST Scheme, including the recommendation of the A-HTRUST Independent Directors, the advice of the IFA and notice of the A-HTRUST EGM and the A-HTRUST Scheme Meeting, will be issued by the A-HTRUST Managers to the holders (the "<u>A-</u>

<u>HTRUST Stapled Securityholders</u>") of the stapled A-HTRUST REIT Units and A-HTRUST BT Units (collectively, the "<u>A-HTRUST Stapled Securities</u>") in due course.
