Grapene has a direct interest in 301,976,732 units in IPIT ("Units"), representing 40.05 per cent. of the total Units. Shoxell had a controlling interest in Grapene.

Brenformexa has converted its non-voting redeemable preference shares in Grapene into voting ordinary shares in Grapene (the "Conversion"). As a result of the Conversion, Brenformexa has a controlling interest in Grapene and Shoxell ceased to have a controlling interest in Grapene. Accordingly, following the Conversion, Shoxell is no longer deemed interested in the 301,976,732 Units held by Grapene.
