SOLARIS BUILDING CLINCHED BCA GREEN MARK PLATINUM AWARD 2019

Singapore, 30 May 2019 – SB REIT Management Pte. Ltd., as manager (the "**Manager**") of Soilbuild Business Space REIT ("**Soilbuild REIT**"), is pleased to announce that Solaris at one-north has won the Green Mark Platinum Award conferred by the Building and Construction Authority of Singapore ("**BCA**") under the BCA Green Mark Scheme for Existing Non-Residential Buildings.

Solaris is a flagship ecological development that has received worldwide recognition for its architectural design and environmental sustainability. Located in the Fusionopolis cluster, Solaris is an iconic state-of-the-art business park development designed to house multinational corporations and large corporates from the info-communications, media and science and engineering research and development industries.

This latest award adds to the multiple accolades Solaris had received for its integrated green design including the FIABCI World Prix d'Excellence Award 2016 (Sustainable Development Category, World Gold Winner), Singapore Property Awards 2015 (Sustainable Development Category), BEI Asia Awards 2014 (Commercial Buildings Category), the National Parks Board Landscape Excellence Assessment Framework Award 2014 and the ASEAN Energy Awards 2013 (Energy Efficient Building – New Existing Category).

The BCA Green Mark Scheme was launched in January 2005 as an initiative to drive Singapore's construction industry towards more environment-friendly buildings. It is intended to promote sustainability in the built environment and raise environmental awareness among developers, designers and builders when they start project conceptualisation and design, as well as during construction. It is also a benchmarking scheme which incorporates internationally recognised best practices in environmental design and performance.
