**PAYMENT OF MANAGEMENT FEES
BY WAY OF ISSUE OF STAPLED SECURITIES IN CAPITALAND ASCOTT TRUST**

CapitaLand Ascott Trust Management Limited (the "**REIT Manager**"), as manager of CapitaLand Ascott Real Estate Investment Trust (the "**REIT**"), and CapitaLand Ascott Business Trust Management Pte. Ltd. (the "**BT Trustee-Manager**"), as trustee-manager of CapitaLand Ascott Business Trust (the "**BT**"), wish to announce that a total of 5,167,858 stapled securities in CapitaLand Ascott Trust ("**Stapled Securities**") have been issued by the REIT Manager and the BT Trustee-Manager as follows:

- (a) 4,433,698 Stapled Securities to Somerset Capital Pte Ltd ("**SCPL**"), an entity nominated by the REIT Manager to receive the Stapled Securities in its place¹ as partial payment of the base fee for the period from 1 April 2026 to 30 June 2026 (both dates inclusive) at an issue price of S\$0.8954 per Stapled Security.

The aforesaid base fee is computed in accordance with the provisions stipulated in the REIT deed of trust dated 19 January 2006 (as amended); and

- (b) 734,160 Stapled Securities to SCPL, an entity nominated by the BT Trustee-Manager to receive the Stapled Securities in its place² as partial payment of the base fee and base performance fee for the period from 1 April 2026 to 30 June 2026 (both dates inclusive) at an issue price of S\$0.8954 per Stapled Security.

The aforesaid base fee and performance fee are computed in accordance with the provisions stipulated in the BT deed of trust dated 9 September 2019 (as amended).

¹ The REIT Manager has sold the 4,433,698 Stapled Securities which it is entitled to receive as payment of its management fee to SCPL, a wholly owned subsidiary of CapitaLand Investment Limited, and in connection with the sale, the REIT Manager has directed that such Stapled Securities be issued directly to SCPL instead of the REIT Manager.

² The BT Trustee-Manager has sold the 734,160 Stapled Securities which it is entitled to receive as payment of its management fee to SCPL, a wholly owned subsidiary of CapitaLand Investment Limited, and in connection with the sale, the BT Trustee-Manager has directed that such Stapled Securities be issued directly to SCPL instead of the BT Trustee-Manager.

With the above-mentioned issue of Stapled Securities, the total number of Stapled Securities in issue is 3,856,603,172. As the 5,167,858 Stapled Securities have been issued to SCPL, the total number of Stapled Securities held by the REIT Manager remains unchanged at 10,501,298 Stapled Securities (0.272%) and the total number of Stapled Securities held by the BT Trustee-Manager remains unchanged at 1,100,215 Stapled Securities (0.028%). However, the CapitaLand Investment Limited Group's aggregated interest in CapitaLand Ascott Trust as at 6 August 2026 increased from 25.07% to 25.17%.
