EXTRAORDINARY GENERAL MEETING TO BE HELD ON 22 JUNE 2022

1. Background

The Board of Directors (the "Board") of Fortress Minerals Limited (the "Company") refers to:

- (a) the COVID-19 (Temporary Measures) Act 2020 passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means;
- (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "Order") which was gazetted on 13 April 2020, subsequently amended on 14 April 2020, 24 April 2020 and 29 September 2020 which sets out the alternative arrangements in respect of, inter alia, general meetings of companies;
- (c) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) (Amendment) Order 2021 which extended the application of alternative arrangements in respect of, *inter alia*, general meetings of companies in the relevant order beyond 30 June 2021, until it is revoked or amended by the Ministry of Law; and
- (d) the joint statement by the Accounting Corporate and Regulatory Authority, Singapore Exchange Regulation and the Monetary Authority of Singapore on 13 April 2020 (as updated on 27 April 2020, 22 June 2020, 1 October 2020 and 4 February 2022) which provides additional guidance on conduct of general meetings during the period when elevated safe distancing measures are in place.

2. Date, time and conduct of Extraordinary General Meeting ("EGM")

The Company is pleased to announce that pursuant to the Order, the EGM of the Company will be convened and held by way of electronic means on <u>Wednesday, 22 June 2022 at 11:30 a.m.</u> (Singapore time) (or as soon thereafter following the conclusion of the Annual General Meeting of the Company to be held at 11:00 a.m. (Singapore time) on the same day).

Representative(s) from the Board will conduct the proceedings of the EGM.

3. Circular, notice of EGM and proxy form

In line with the relevant provisions under the Order, printed copies of the circular, notice of EGM and proxy form will not be despatched to shareholders.

The circular, notice of EGM and proxy form will be sent to shareholders solely by electronic means via publication on our Company's website and will also be made available on the SGX website¹.

4. No personal attendance at EGM

Due to the current COVID-19 situation in Singapore, <u>shareholders will not be able to attend the</u> <u>EGM in person</u>.

5. Alternative arrangements for participation at the EGM

Shareholders may participate at the EGM by:

- (a) observing and/or listening to the EGM proceedings via live audio-visual webcast or live audio-only stream;
- (b) submitting questions in advance of the EGM; and
- (c) appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the EGM.

Details of the steps for pre-registration, pre-submission of questions and voting at the EGM are set out in the **Appendix** to this announcement.

6. Persons who hold shares through relevant intermediaries.

Persons who hold shares of the Company through relevant intermediaries (as defined in section 181 of the Companies Act 1967), including CPF and SRS investors, and who wish to participate in the EGM by:

- (a) observing and/or listening to the EGM proceedings via live audio-visual webcast or live audio-only stream;
- (b) submitting questions in advance of the EGM; and/or
- (c) appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the EGM,

should contact the relevant intermediary (which would include, in the case of CPF and SRS investors, their respective CPF Agent Banks and SRS Operators) through which they hold such shares not less than **seven (7) working days** before the EGM in order for the necessary arrangements to be made for their participation in the EGM.
