RECEIPT OF CREDITOR'S APPLICATION FOR JUDICIAL MANAGEMENT

The Board of Directors (the "**Board**") of Alpha DX Group Limited (the "**Company**") and together with its subsidiaries, the "**Group**") wishes to announce that the Company has been notified that an application has been filed on 12 January 2023 by Kydon Holdings Pte Ltd (the "**Creditor**"), in the General Division of the High Court of the Republic of Singapore (the "**Court**"), applying to the Court for an order to place the Company under judicial management pursuant to Section 91 under Part 7 of the Insolvency, Restructuring and Dissolution Act 2018 (the "**JM Application**"). Pursuant to the JM Application, the Creditor is seeking to appoint Mr Tan Wei Cheong and Mr Lim Loo Khoon of Deloitte & Touche LLP jointly and severally as the judicial managers of the Company. The proposed judicial managers will manage the affairs, business and property of the Company.

In connection with the JM Application, the Creditor has also applied to the Court for an order to place the Company under interim judicial management and for Mr Tan Wei Cheong and Mr Lim Loo Khoon of Deloitte & Touche LLP to be appointed, jointly and severally, as interim judicial managers of the Company, pending the determination of the JM Application (the "**IJM Application**").

The Company is presently reviewing the JM Application and the IJM Application and taking legal advice on their proposed course of action.

The Company will continue to keep its stakeholders updated and will make the appropriate announcements as and when there are any material updates or developments, in compliance with the SGX-ST Listing Manual Section B: Rules of Catalyst.
