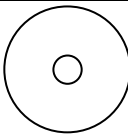

- Part II - (1) **IMPORTANT:** This proxy form is not valid for use by investors holding shares in the Company through relevant intermediaries (as defined in Section 181 of the Companies Act 1967 of Singapore) ("**Investors**") (including investors holding shares through Central Provident Fund ("**CPF**") and Supplementary Retirement Scheme ("**SRS**") ("**CPF/SRS investors**")) and shall be ineffective for all intents and purposes if used or purported to be used by them. An Investor who wishes to vote should approach his/her relevant intermediary as soon as possible to specify voting instructions. A Depositor(s) can appoint the Chairman of the Meeting as his/her/its proxy, but this is not mandatory. An Appointee need not be a member of the Company.
