# LIVE WEBCAST OF THE COMPANY'S ANNUAL GENERAL MEETING TO BE HELD ON FRIDAY, 27 NOVEMBER 2020

## 1. INTRODUCTION

The board of directors ("**Board**") of Jawala Inc. (the "**Company**" and together with its subsidiary, the "**Group**") refers to:

- (a) the COVID-19 (Temporary Measures) Act 2020 passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means;
- (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "Order") which was gazetted on 13 April 2020, and which sets out the alternative arrangements in respect of, inter alia, the holding of general meetings of companies (the "Alternative Arrangement");
- (c) the Amendments to the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings) Orders (the "**Meetings Orders**") which came into force on 29 September 2020; and
- (d) the joint statement released by the Accounting and Corporate Regulatory Authority, the Monetary Authority of Singapore and Singapore Exchange Regulation on 13 April 2020 (and subsequently updated on 27 April 2020, 22 June 2020 and 1 October 2020), providing additional guidance on the conduct of general meetings during the period when elevated safe distancing measures are in place.

## 2. DATE, TIME AND CONDUCT OF ANNUAL GENERAL MEETING ("AGM")

With reference to the Alternative Arrangement, the Company wishes to inform that it shall hold its AGM on Friday, 27 November 2020 at 2.00 p.m. by electronic means through "live" audio-visual webcast or "live" audio-only stream to transact the businesses set out in the Notice of AGM dated 5 November 2020 ("Notice of AGM").

# 3. NO DESPATCH OF PRINTED COPIES OF ANNUAL REPORT 2020, NOTICE OF AGM AND PROXY FORM

In line with the provisions under the Order, **no printed copies of the Annual Report 2020, Notice of AGM and proxy form will be despatched** to the members of the Company.

A member will need an internet browser and PDF reader to view the documents on SGXNet and the Company's website.

#### 4. NO PERSONAL ATTENDANCE AT THE AGM

Due to the current COVID-19 restriction orders in Singapore, **members will not be able to attend the AGM in person**. Please see paragraph 5 below for the alternative arrangements.

### 5. ALTERNATIVE ARRANGEMENTS FOR PARTICIPATION AT THE AGM

Members may participate at the AGM by:

- (a) observing and/or listening to the AGM proceedings via "live" audio-visual webcast or "live" audio-only stream;
- (b) submitting questions (if any) in advance of the AGM; and/or
- (c) appointing the Chairman of the AGM as proxy to attend, speak and vote on the members' behalf at the AGM.

Details of the steps and deadlines for pre-registration, submission of questions in advance and voting at the AGM are set out in Paragraph 7 below and the Notice of AGM.

### 6. PERSON HOLDING SHARES THROUGH RELEVANT INTERMEDIARIES

Persons holding shares through Central Provident Fund ("CPF") and Supplementary Retirement Scheme ("SRS") ("CPF/SRS investors") who wish to participate in the AGM by (a) observing and/or listening to the AGM proceedings via "live" audio-visual webcast or "live" audio-only stream; and/or (b) submitting questions (if any) in advance of the AGM, should follow the steps for pre-registration and/or pre-submission of questions set out in Paragraph 7 below and the Notice of AGM.

CPF/SRS investors who wish to appoint the Chairman of the AGM as proxy to attend, speak and vote on their behalf should approach their respective CPF Agent Banks or SRS Operators to submit their voting instructions by 2.00 p.m., on 17 November 2020, being seven (7) working days before the date of the AGM.

Persons who hold shares of the Company through relevant intermediaries ("**Investors**") (other than CPF/SRS investors) who wish to participate in the AGM by (a) observing and/or listening to the AGM proceedings via "live" audio-visual webcast or "live" audio-only stream; (b) submitting questions (if

any) in advance of the AGM; and/or (c) appointing the Chairman of the AGM as proxy to attend, speak and vote on their behalf at the AGM, should contact the relevant intermediaries through which they hold such shares as soon as possible in order to make the necessary arrangements for them to participate in the AGM.
