30,832,000 ordinary shares in the share capital of Citrine Capital Pte. Ltd. were transferred from Top Fortune Capital Ltd ("TFC BVI"), a company incorporated in the British Virgin Islands, to Top Fortune Capital Pte. Ltd. ("TFC SG"), a company incorporated in Singapore, for S\$21,659,986.35. Mr Tan Chee Beng is the sole shareholder and director of both TFC BVI and TFC SG. The transfer was to reduce operating costs, due to the increasing compliance, regulatory and administrative costs of British Virgin Islands entities. See item 10.

30,832,000 ordinary shares in the share capital of Citrine Capital Pte. Ltd. ("Citrine"), representing 94% of the share capital of Citrine, were transferred from Top Fortune Capital Ltd ("TFC BVI"), a company incorporated in the British Virgin Islands, to Top Fortune Capital Pte. Ltd. ("TFC SG"), a company incorporated in Singapore, for S\$21,659,986.35 which represents the net asset value of the shares transferred. Such share transfer is being undertaken as a result of an internal restructuring exercise. The transfer was to reduce operating costs, due to the increasing compliance, regulatory and administrative costs of British Virgin Islands entities.

Mr Tan Chee Beng is the sole shareholder and director of both TFC BVI and TFC SG. There is no change in the ultimate beneficial ownership of the shares in Citrine and there is no change in the deemed interests of Mr Tan Chee Beng in Goodland Group Limited.

There is no change in the deemed interests of Madam Koh Chin Kim in Goodland Group Limited.

Madam Koh Chin Kim is deemed to have an interest in:

- (a) 21,208,700 shares held by her daughter, Ms. Tan Bee Bee;
- (b) 39,744,500 shares held by her son, Dr. Tan Chee Tiong;
- (c) 27,795,000 shares held by her son, Mr. Tan Chee Beng;
- (d) 14,000,000 shares held by Mr. Tan Chee Beng's nominee, DB Nominees (Singapore) Pte Ltd;
- (e) 2,809,200 shares held by Mr. Tan Chee Beng's nominee, United Overseas Bank Nominees Pte Ltd;
- (f) 79,000,794 shares registered in the name of Citrine; and
- (g) 56,500,000 shares registered in the name of Hong Leong Finance Nominees Pte Ltd through Citrine.

In relation to (f) and (g), TFC SG is wholly-owned by Mr. Tan Chee Beng. Accordingly, Mdm Koh Chin Kim is deemed to have an interest in the shares set out in (f) and (g) above.
