CSOP SG ETF SERIES I (THE “FUND”)

• **CSOP FTSE ASIA PACIFIC LOW CARBON INDEX ETF (THE “SUB-FUND”)**

You are currently invested in the Sub-Fund under the Fund in which we, CSOP Asset Management Pte. Ltd., act as manager. We are writing to you to inform you that with effect from 8 May 2026 (the “**Effective Date**”), the index provider, FTSE Russell, will rename the index tracked by the Sub-Fund from the “FTSE Asia Pacific Low Carbon Select Index” to the “FTSE Asia Pacific Select Index”. In connection with this change, the name of the Sub-Fund will also be updated to the “CSOP FTSE Asia Pacific Select Index ETF”. The SGX Full Name, SGX Counter Name and CDP Statement Name will also be changed as follows:

The renaming of the index will not affect its existing methodology for selecting constituent companies, conducting periodic reviews, or determining index weightings. Accordingly, the renaming of the Sub-Fund will have no significant impact on the way the Sub-Fund is currently being managed. There will be no changes to the investment objective, focus, approach or ESG fund classification of the Sub-Fund arising from the renaming of the Sub-Fund.

Please note that the Monetary Authority of Singapore will concurrently be notified of the changes described herein.
