

ISSUE AND ALLOTMENT OF SHARES PURSUANT TO THE EXERCISE OF OPTIONS UNDER THE EXECUTIVES' SHARE OPTION SCHEME

The Board of Directors of Venture Corporation Limited (the "Company") wishes to announce that on 18 January 2021 the Company issued and allotted:

- (1) an aggregate of 9,000 ordinary shares in the capital of the Company at the exercise price of \$\$8.410 each pursuant to the exercise of options granted under the Venture Corporation Executives' Share Option Scheme 2015 ("ESOS Scheme 2015"); and
- (2) an aggregate of 63,000 ordinary shares in the capital of the Company at the exercise price of S\$12.400 each pursuant to the exercise of options granted under the ESOS Scheme 2015.

The above-mentioned new shares have been listed and quoted on the Singapore Exchange Securities Trading Limited on 20 January 2021.

The new shares issued rank pari passu in all respects with the existing shares of the Company.

Pursuant to the above issue and allotment of new shares, the number of issued and paid-up shares in the capital of the Company is 291,191,577 ordinary shares (including 1,055,000 treasury shares).
