(i) Croesus Merchants International Pte. Ltd ("CMIPL") has a direct interest in an aggregate of 5,425,000 units in CRT (the "Units") and (ii) Croesus Retail Asset Management Pte. Ltd. ("CRAM") has a direct interest in an aggregate of 2,239,000 Units. CMIPL is the ultimate holding company of CRAM and is therefore deemed to be interested in the Units held by CRAM.

On 9 October 2015, CMIPL received its provisional allotment of 1,686,080 Rights Units pursuant to the Rights Issue (as defined below), comprising (i) 1,193,500 Rights Units provisionally allotted to CMIPL directly and (ii) 492,580 Rights Units provisionally allotted to CRAM.

On 12 October 2015, CMIPL has accepted its provisional allotment of 1,193,500 Rights Units pursuant to the Rights Issue.

Mr Yong Chao Hsien Jeremy has a 49% beneficial ownership in CMIPL and is therefore deemed to have an interest in the Units (including the provisional allotment of Rights Units) held by CMIPL directly and held by CMIPL through CRAM.
