## Appointment of Executive Director and Deputy CEO

The Board of Directors of Micro-Mechanics (Holdings) Ltd. Prior to joining Micro-Mechanics, Kyle had gained valuable technical and hands-on experience in the engineering field at leading technology companies such as Agilent Technologies, Inc., Apple and NASA Jet Propulsion Laboratory. He earned a Bachelor of Science in Physics with a minor in Mathematics from the University of California Los Angeles and double Masters of Science degrees in Mechanical Engineering and Engineering Management from the University of Southern California.

Kyle is the eldest son of the Group's founder and CEO, Mr Christopher Reid Borch. Kyle's appointments dovetail with the Group's succession planning. The Board, having reviewed his qualifications and work experience, warmly welcomes Kyle as a new board member and Deputy CEO.
