All of the above information are obtained from Accordia Golf Co., Ltd. (“Accordia Golf”) as the manager of the 89 golf courses (including golf course related assets relating to such golf courses) located in Japan in the portfolio (the “Initial Portfolio”) of Accordia Golf Trust (“AG Trust”). The information is on a best estimates basis and unaudited.

The information in respect of the months of April to July are presented for information only and were obtained from Accordia Golf Co., Ltd.. AG Trust’s distributable cash flow does not include cash flows during this period as AG Trust only completed the acquisition of its initial portfolio on 1 August 2014, being the date of its listing on the Main Board of Singapore Exchange Securities Trading Limited.

In October 2014, the number of visitors to the 89 golf courses comprised in the Initial Portfolio of AG Trust saw an on-year increase of 3.4%, and the utilization rate also rose by 3.2 percentage points. October is typically typhoon season in Japan, and this October saw a number of typhoons occurring over the weekends and affecting AG Trust’s golf course operations. But conditions this year was less severe compared to last October, resulting in an improvement in the number of visitors and utilization rate.
