## ALLOTMENT AND ISSUANCE OF SHARES PURSUANT TO WARRANT EXERCISE

The Board of Directors (the “**Board**”) of ValueMax Group Limited (the “**Company**”) wishes to announce the number of issued ordinary shares of the Company has increased from 940,063,259 ordinary shares (exclusive of 100,000 treasury shares) to 940,103,259 ordinary shares by way of allotment and issuance 40,000 new ordinary shares in the capital of the Company pursuant to the exercise of 40,000 warrants at the exercise price of S\$0.36 each, on 19 December 2025.
