## **ALLOTMENT AND ISSUE OF SHARES PURSUANT TO THE EXERCISE OF WARRANTS**

The board of directors (the “**Board**”) of F J Benjamin Holdings Ltd (the “**Company**”) refers to the Company’s circular to its shareholders dated 15 February 2018 and the offer information statement dated 12 March 2018 in relation to the Rights cum Warrants Issue (as defined therein).

The Board wishes to announce that the number of issued and paid-up ordinary shares in the capital of the Company (“**Shares**”) has increased from 1,015,930,183 Shares to 1,021,416,983 Shares by way of allotment and issuance of 5,486,800 new Shares (“**New Shares**”) on 29 March 2021 pursuant to the exercise of 5,486,800 warrants granted under the Rights cum Warrants Issue at the exercise price of S\$0.04 each.

The New Shares, which rank *pari passu* in all respects with, and carry all rights similar to, the existing issued Shares, are expected to be listed and quoted on the Singapore Exchange Securities Trading Limited with effect from 9.00 a.m. on or around 31 March 2021.

Following the aforesaid exercise of warrants, there are 570,970,616 outstanding warrants with an exercise price of S\$0.04 each, expiring at 5.00 p.m. on 5 April 2021.
