ALLOTMENT AND ISSUE OF SHARES PURSUANT TO WARRANT EXERCISE

The Board of Directors of Second Chance Properties Ltd (the "**Company**") and together with its subsidiaries, the "**Group**") wishes to announce that the number of issued ordinary shares of the Company has increased from 926,431,722 ordinary shares to 926,521,722 ordinary shares by way of the allotment and issuance of 90,000 new ordinary shares in the capital of the Company (the "**New Shares**") pursuant to the exercise of 90,000 warrants at the exercise price of S\$0.25 per share, on 8 February 2023.
