Temasek Holdings (Private) Limited ("Temasek") does not have any direct interest in the voting shares of Dyna-Mac Holdings Ltd. (the "Listed Issuer").

However, Temasek is filing this notification form to report a change in deemed interest from 25.10% to 24.96% in voting shares of the Listed Issuer as a result of the sale of 1,429,000 voting shares of the Listed Issuer by Fullerton Fund Management Company Ltd. as investment manager (the "Transaction").

The filing of Temasek's deemed interest arises from the aggregation of the deemed interests held by Fullerton Fund Management Company Ltd. ("FFMC") and Keppel Corporation Limited ("KCL").

(A) Temasek's deemed interest via FFMC 0.53%


- (i) 0.53% of voting shares of the Listed Issuer are held in third party funds ("Third Party Funds") which are managed by FFMC.
- (ii) FFMC has a deemed interest in the voting shares of the Listed Issuer held in the Third Party Funds.
- (iii) Temasek owns 100% of FFMC, an independently managed Temasek portfolio company.

(B) Temasek's deemed interest through KCL 24.43%

- (i) KS Investments Pte Ltd ("KSIPL") has a direct interest in 24.43% of voting shares of the Listed Issuer.
- (ii) KSIPL is a wholly owned subsidiary of Keppel Offshore & Marine Limited, which is in turn a wholly owned subsidiary of KCL.
- (iii) Temasek owns a more than 20% interest in KCL, an independently managed Temasek portfolio company.
